## Conclusion by Asst. Prof. Saatish Pandey (Moderator):

Asst. Prof. Saatish Pandey appreciated the students for their participation and confident delivery.

However, he pointed out a few key drawbacks observed during the debate:

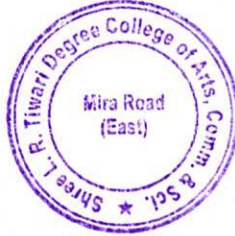
1. **Inadequate use of sections and provisions:** Many participants presented arguments without quoting relevant sections of the Income Tax Bill, which weakened the legal and factual foundation of their points. He emphasized the importance of supporting arguments with specific clauses or provisions.
2. **Generalization of arguments:** Some students relied heavily on opinions or broad statements rather than data-driven points, and failed to distinguish between the old and proposed provisions of the bill.
3. **Lack of structured flow and teamwork:** A few teams lacked coordination in the flow of arguments, leading to repetition and inconsistent messaging.

He encouraged students to prepare with better technical references, including sections and real-world examples, to strengthen future performances.

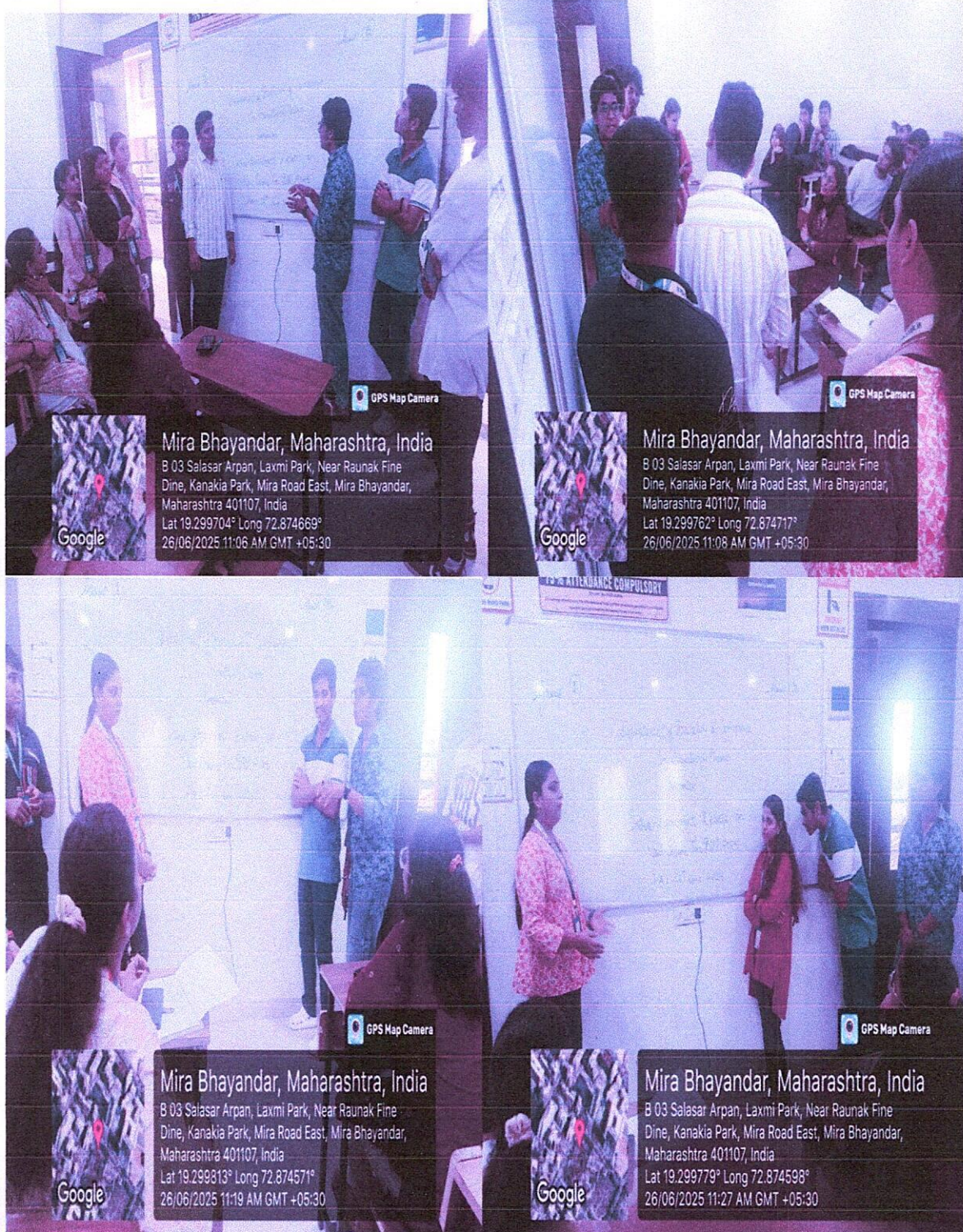

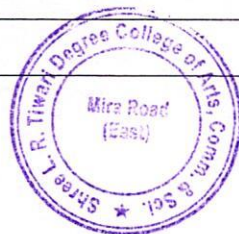
